Sealed competitive quotations from Registered and reputed firms are invited by the undersigned on behalf of the Kendriya Vidyalaya AFS Akkulam for the White wash and colour wash of the building of KV AFS Akkulam and its staff quarters, as per the schedule attached.

5	Scrubbing , Cleaning and Painting with synthetic enamel paint of premium brands on Glassed windows with frames and cross bars , both sides of the Vidyalaya and Staff Quarters	WINDOWS
6	Scrubbing , Cleaning and Painting with synthetic enamel paint of premium brands on Glassed ventilators with frames and cross bars , both sides	VENTILLATORS

9	Scrubbing, Cleaning and Painting with synthetic enamel paint of premium brands on metallic pillars and roofing of assembly area of the Vidyalaya (Scraping of rusted portions of the pillars is compulsory along with painting with metal primer, before doing metallic painting) of assembly area Note : (No need of painting the roofing sheets)	ASSEMBLY AREA
10	Rubbing, Cleaning and Painting with good quality Varnish of premium brands in the areas which are already coated with Varnish (color of the stain to be added , if any will be as per the choice of the purchaser, will intimate after awarding the contract),	VARNISH

12. Terms and conditions

- a) The contract shall be for the Work of the mentioned items for Kendriya Vidyalaya, AFS Akkulam and its staff quarters. The bidder shall quote the rates for items of work in the attached format ,separately in Annexure I, II , II and IV
- b) All taxes, GST, Duties and other levies payable, shall be included in the total price. They shall be quoted separately. No additional payment will be done for anything that is not quoted.
- c) The rates quoted by the bidder shall be fixed for the whole duration of the contract.
- d) Each bidder shall submit only one quotation for each Annexures (I , II , III and IV separately, in the same format supplied by the Vidyalaya. No other formats are acceptable.
- e) The bid should be submitted along with EMD for Rs.5000/- (Five Thousand Only) by Bank Draft in favour of VVN Account of Kendriya Vidyalaya Akkulam.
- f) The firm should enclose supporting documents regarding registration of GST/VAT/ST/IT PAN(as applicable)
- g) The complete painting of every area mentioned shall be done with premium quality paint of specified type of reputed brand and specified quality. The brand and quality will be tested /verified frequently and has to be approved by the monitoring committee.
- h) Color washing shall be done with premium branded quality interior/ exterior emulsion paints, as applicable
- i) **Colour of the paint in various areas will be as per the discretion and decision of the Painting Monitoring Committee of the Vidyalaya and will be informed at the time of awarding the contract.**
- j) Scrapping, rubbing and cleaning to be done as per the satisfaction of the monitoring committee of the School
- k) The bidder to bring color cards of premium brand to the Vidyalaya for selection and approval
- l) The rates quoted will be applicable for both Vidyalaya and staff quarters.

13. Quoting of rates- Clarification

There will be four annexures meant for quoting the rates with 04 specifications

Annexure I- One coat without material – Only labour contract for one coat

Annexure II- One coat with material – material and labour for one coat

Annexure –III- Two coats without material – Only labour contract for two coat

Annexure IV- Two coats with material – material and labour for two coat

- a) For Interior, Exterior & Ceiling rate to be quoted for Sq.Mtr.
- b) For Doors, Windows and Ventilator , rate to be quoted for units
- c) For Hand Rails rate to be quoted for running meter.
- d) For Grills /Metallic Coverings rate to be quoted for Sq.Mtr (With Grills fully closed).
- e) For Assembly area , rate to be quoted for Sq.Mtr , measured from floor
- f) For Varnish , rate to be quoted for Sq. Mtr
- g) For Black Boards, rate to be quoted for Units

14. Validity of Quotations

The quotation shall remain valid for a period of one year from the date of opening the quotations.

15. Evaluation of Quotations

The purchaser will evaluate and compare the quotations determined to be substantially responsive, ie, which are

- a) Properly signed
- b) Quoted as per guidelines and specifications mentioned
- c) Conforming to the terms and conditions and specifications.
- d) The bidder who has quoted for partial work of any one or more items(s) of each annexure shall be considered as non-responsive in that annexure of quotation.

16. Award of Contract

- a) The purchaser shall award the contract to the bidder whose quotation has been determined to be substantially/technically responsive and whose **total sum of unit rates for all the work items put together in each annexure** is the lowest (Separate for Annexure I, II, III and IV).

Note: Work will be awarded as per requirement with/without materials , One or Two coats , as per requirement of the Vidyalaya and availability of fund

- b) The bidder whose bid is accepted shall be notified about the award of contract, by the Office, prior to the expiration of the quotation validity period.
- c) Normal commercial warranty/ guarantee shall be applicable to the materials and service provided.
- d) Payment shall be made within 15 days after the job is completed and accepted by the Vidyalaya in all respect.
- e) Notwithstanding the above the purchaser reserves the right to accept or reject any quotations and to cancel the bidding process and reject all quotations at any time prior to the award of contract.

- f) The awardee of the contract shall be liable to compensate the damages caused to the building or the materials in the building, if any, during the work. For such damages if any, compensation will be deducted from the payment to be made for the work as per quotation.
- g) The awardee of the contract shall be liable to pay compensation/penalty if the said work is not completed within the stipulated time.
- a) The successful bidder has to deposit performance security of an amount equivalent to 10% of the total cost of the works in favour of Principal Kendriya Vidyalaya AFS Akkulam in the form of Demand draft. At the time of making payments of the work, TDS will be deducted @ 2%, as per rules.

17. Additional terms and conditions.

- b) The awardee of the contract shall begin the work only after obtaining the approval of the PAINTING MONITORING COMMITTEE with regard to the quality of the Material to be used for the work.
- c) The tools for cleaning and painting such as Brushes, Power washing tools, scrapers, ladders, etc to be brought by the awardee and the rates quoted should include all these. At no cost, such materials shall be provided by the Vidyalaya.
- d) All the display boards, pictures, etc presently fixed on the walls shall be removed before the painting and refixed after the work by the awardee of the contract.
- e) Complete and perfect cleaning of the floor, fans, lights and furniture shall be done by the awardee after the painting.
- f) No painting to be started before the cleaning of that particular block is completed.
- g) The second coating (If required and demanded by the Vidyalaya) to be started only after finishing the first coating and after the direction from the Vidyalaya and measurement to be taken in the presence of the Painting Monitoring Committee
- h) It is the responsibility of the bidder to see that the exact color is shining (as per the shade shown in the catalogue of the brand of the paint) after the second coating ie the old color to be totally hidden. No shade of the old color to be seen.
